- Dr. Williams discussed the President's Board Report for September 2022 with special emphasis on the following:
 - **a.** A special thank you to Trustee Matthews for the idea of contacting ECU for assistance with the Nursing Department.
 - b. Develop a Weld to Work IET (Integrated Educational Training) Pathway. Students will participate in college and career readiness classes, workforce classes, and soft skills training simultaneously. This will allow students who do not have a high school diploma to enroll in credit pathways while completing a high school equivalency.
 - c. Dr. Williams gave a report on the enrollment update for summer and fall. She stated the curriculum fall enrollment totals are not final as there is still a second eight-week term. Continuing Education and College and Career Readiness will have until December 15th to reach their fall enrollment goals.
